Terms & conditions - Individual registration

Registration

- ◆ **1st registration deadline** (*Only applicable for ISS/SIC Members*) – until **Thursday, 31 January 2019**, midnight CET.
 - Should your registration remain unpaid on Thursday, 14 February 2019, the fee will be upgraded.
- ◆ **2nd registration deadline** – until **Tuesday, 30 April 2019**
 - Should your registration remain unpaid on Tuesday 14 May 2019, the fee will be upgraded.
- ◆ **3rd registration deadline** – until **Monday, 24 of June**
 - Should your registration remain unpaid on Monday, 8 July 2019, the fee will be upgraded.
- ◆ **4th registration deadline** – applicable for all new registrations after **Tuesday, 25 June 2019**

Registration modification & cancellation

All cancellations are to be sent to MCI Suisse SA in writing (fax or email), including social and networking events if any.

For cancellations received before **Tuesday, 30 April 2019** deposits will be refunded less **25% administrative charge**. After this date, no refunds will be possible

A handling fee of **EUR 40.- per registration** will be charged for every registration modification received **after Wednesday, 10 July 2019**.

If a badge is lost or forgotten, an administrative fee of **EUR 80.-** will be charged for the reprint of the badge after identity verification (passport, driving license or other recognised identification documents).

Hotel accommodation

MCI acts as an agent for accommodation bookings and WCS accepts no responsibility for any recommendations given or any transactions made.

Payment:

For hotel bookings, a deposit payment covering the first night is required with your reservation. Your booking will be confirmed upon receipt of your hotel deposit. This prepaid deposit will be deducted from your final hotel bill when checking out from the hotel.

For bookings of 2 rooms or more, the full payment is required to confirm your reservation.

Additional expenses such as mini-bar and telephone, must be paid directly to the hotel when checking out

Your credit card will be registered but no debit will be made. Your card will only be charged in case of no-show, cancellation or modification as per conditions below.

Important: to guarantee the reservation, your full credit card details are required. Please take note that online guarantees by credit card require "3D secure" identification.

Neither MCI nor WCS will pay or be liable to pay for the individual bookings and does not provide the Hotel with any guarantee. Important note: if your registration is covered by your company/institution who is established in the venue's country, please make sure to provide your company/institution VAT number during your registration process in order to benefit from the reverse charge mechanism (registration fee is invoiced with no VAT).
